- 07-01-09 1** The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at 9:30 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Dennis Wright, Vernon Beernink, Mark Sybesma, John Degen and Arlyn Kleinwolverink.

- 07-01-09 3** Anita Van Bruggen, County Recorder submitted the Recorders Quarterly Report, it was accepted for information.
