

**MINUTES OF SIOUX COUNTY BOARD OF SUPERVISORS**  
**MEETING HELD ON JANUARY 16, 2007**

- 07-01-16 1** The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at 9:30 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Dennis Wright, Vernon Beernink, Mark Sybesma, John Degen and Arlyn Kleinwolterink.
- 07-01-16 2** Minutes of the meeting held on January 9, 2007, were submitted and the Chairman declared them approved.
- 07-01-16 3** Coleman McAllister, County Attorney, reviewed ongoing activities in his office.
- 07-01-16 4** Shane Walter, County Community Services Director, distributed the MH/DD Monthly Expenditure Report for December 2006.
- 07-01-16 5** Jim Raymond, Zoning Administrator, presented an expansion proposal for a swine operation in Holland Township Section 3 owned by Mark Van Roekel. No comments, either written or verbal were received by the Auditor. Motion by Beernink and supported by Kleinwolterink that a letter will be forwarded to the DNR stating that no comments were received. Motion carried, unanimous in favor.
- 07-01-16 6** Raymond advised the Board that he had compiled a job description for a full-time Zoning Administrator. He has incorporated that position into the 2007/2008 County Budget. Reported that a Planning and Zoning Commission meeting will be held on Thursday, January 18 at 1:00 p.m.
- 07-01-16 7** Jim Raymond, Emergency Management Director, reported that the Sioux Center antenna will be moved from the water tower to the KSOU radio tower. After that move is accomplished, other sites throughout the County will be updated.
- 07-01-16 8** Randy Feenstra, County Treasurer, distributed the semi-annual Treasurer's Report for information.
- 07-01-16 9** Tom Fleming, representative of Blue Cross Health Insurance informed the Supervisors that Health insurance coverage for FY 2007/2008 will increase 3.61%.
- 07-01-16 10** Condemnation Board Members were reviewed and contacts will be made with possible members for 2007.
- 07-01-16 11** Doug Julius, County Engineer, requested a signature on title sheet for Bridge Replacement Project. Motion by Wright and supported by Degen to rename the portion of Highway 60 that was replaced in Hospers to Hospers Drive. Motion carried, unanimous in favor.
- 07-01-16 12** Motion by Kleinwolterink and supported by Wright to authorize the Chairman to acknowledge the additional work done by Williams and Company on the 2006 audit and to reimburse that company \$1,750 for that work. Motion carried, unanimous in favor.
- 07-01-16 13** The 2007/2008 County Budget worksheets were distributed to the Supervisors for information.
