MINUTES OF SIOUX COUNTY BOARD OF SUPERVISORS MEETING HELD ON JANUARY 28, 2003

The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at 9:30 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Loren Bouma, Vernon Beernink, Mark Sybesma, Bernard L. Smith and Stanley L. De Haan.

Minutes of January 14, 2003 were read and on motion and vote stand approved as read.

Motion by Beernink and supported by De Haan to go into executive session upon the recommendation of Melissa O'Rourke, County Attorney, according to Section 21.5(1c), Code of Iowa, to discuss strategy with counsel in matters that are presently in litigation or where litigation is imminent where its disclosure would be likely to prejudice or disadvantage the position of the governmental body in that litigation. The subject matter is Multimedia Telesys, Inc., a Delaware Corporation v. Sioux County. Roll Call on Vote: Bouma, Yes; Beernink, Yes; Sybesma, Yes; Smith, Yes; and De Haan, Yes. Carried, unanimous in favor.

Motion by Beernink and supported by De Haan to go out of executive session according to Section 21.5(1c), Code of Iowa. Roll Call on Vote: Bouma, Yes; Beernink, Yes; Sybesma, Yes; Smith, Yes; and De Haan, Yes. Carried, unanimous in favor.

David VanNingen, Executive Director of Hope Haven, Inc.; Duane Obbink, Business Manager of Hope Haven, Inc.; and Jeri Hass, Executive Director of Hope Haven Residential Training Center, met with the Board this date to submit and discuss a budget request in an amount of \$257,071.00 for fiscal year 2004.

Shane Walter, County Community Services Director, was present for the aforementioned presentation.

Motion by Bouma and supported by De Haan to approve and authorize the Chairman to sign a Letter of Agreement with the Decategorization Governance Board of Cherokee, Lyon, Plymouth and Sioux Counties. The purpose is to contract with the Northwest Iowa Community Empowerment Board's fiscal agent – Sioux County – to provide the funding reimbursement for Decat Empowerment Service Coordination activities. Carried, unanimous in favor.

Jim Schwiesow, County Sheriff, met with the Board this date to review and compare the two lowest bids submitted by Iowa Office Supply of Storm Lake and Canfield Interiors of Sioux Falls, South Dakota to provide furnishings for the new Sioux County Public Safety Center at a bid letting held at 11:00 o'clock a.m. on January 14, 2003.

Motion by Smith and supported by De Haan to accept the low bid from Iowa Office Supply of Storm Lake in a total amount of \$105,435.68 after deletions in an amount of \$3,601.39 were made from the original bid submitted on January 14, 2003 to provide furnishings for the new Sioux County Public Safety Center. Their bid also includes an amount of \$3,271.00 that will be billed to Sioux County separately for design work and preparation of the bid specifications to assist Sioux County with the bid letting. Carried, unanimous in favor.

Motion by Bouma and supported by Beernink to approve and sign a certificate appointing the required number of real estate owners in townships, real estate owners in cities, real estate brokers and bankers in Sioux County to serve on the County Condemnation Board for Eminent Domain in compliance with Section 6B.4, Code of Iowa, as shown on file in the County Auditor's Office. Carried, unanimous in favor.

Mark Kemper, Director of GIS Project Management for The Sidwell Company; and Arlette McNamara, GIS Production Manager for The Sidwell Company, met with the Board this date to report on the progress of the Sioux County GIS mapping project and present a power point

The Iowa Department of Transportation and D.A.I.R. Railroad plan to replace an at grade crossing on Iowa Highway 12 between 460th St. and Iowa Highway 10. Carried, unanimous in favor.

Motion by Bouma and supported by De Haan to approve and authorize the Chairman to sign an Iowa Department of Transportation Agreement for Federal-Aid Highway Bridge Replacement and Rehabilitation (HBRR) Program Project for Sioux County Project No. BROS-CO84(103)--8J-84. Carried, unanimous in favor.

Doug Julius, County Engineer, reviewed and identified 18 miles of Class B level roads in

Sioux County that may be potential areas for the Sioux County Sportmen's Club to seed with native

grasses to create more wildlife habitat.

Rob Klocke, Executive Director of the County Conservation Board; Don Brommer and John

Degen, members of the County Conservation Board; and Dan Harskamp, representative for the

Sioux County Sportmen's Club, were present for the aforementioned native grasses seeding matter.

Motion by Smith and supported by De Haan to approve payment of claims as presented by
