

**MINUTES OF SIOUX COUNTY BOARD OF SUPERVISORS**  
**MEETING HELD ON JANUARY 30, 2007**

- 07-01-30 1** The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at 9:30 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Dennis Wright, Vernon Beernink, Mark Sybesma, John Degen and Arlyn Kleinwolterink.
- 07-01-30 2** Dan Altena, County Sheriff, introduced new deputy Jose Mora to the Supervisors. Present for this introduction was Deputy Gerry Holtrop. Altena presented the Sheriff's Department budget request for FY 2007/2008.
- 07-01-30 3** Randy Feenstra, County Treasurer, presented the Treasurer's Department budget request for FY 2007/2008.
- 07-01-30 4** Minutes of the meeting held on January 16, 2007, were submitted and the Chairman declared them approved.
- 07-01-30 5** Anita Van Bruggen, County Recorder, presented the Recorder's Department budget request for FY 2007/2008.
- 07-01-30 6** Committee Reports: Wright reported that the Residential Training Center rental agreement was discussed with Hope Haven Director, David Van Ningen. Waving the rent payment would enable Hope Haven time to devise a plan to reorganize the use of the facility or come up with an additional revenue source. Decision deferred to the February 6, 2007 board meeting. Sybesma reported on an Empowerment Board Meeting. Kleinwolterink reported on a Mental Health meeting.
- 07-01-30 7** Donald Jacobsma, Sioux County Fair Budget Board, presented the request from the Fair Board for FY 2008: \$25,000.00. Jim Den Herder reviewed a proposal for a 60 x 88 Morton Building to replace the current Hospital Auxiliary Building. This building will be air conditioned and heated so it would be available year round.
- 07-01-30 8** Doug Julius, County Engineer, reported that stockpiling is complete at the Sioux Center Shop and progressing at various other sites.
- 07-01-30 9** Coleman McAllister, County Attorney, updated the Board on a case he is defending for the Board of Adjustment. McAllister distributed information regarding work done by the Victim/Witness Coordinator – some of which were mandated by recent legislation. The County Attorney's Department budget request for FY 2007/2008 was submitted.
- 07-01-30 10** The Chairman adjourned the meeting at 11:50 a.m. until Tuesday, February 6, 2007.
