

MINUTES OF SIOUX COUNTY BOARD OF SUPERVISORS
MEETING HELD ON FEBRUARY 22, 2011

11-02-22 1 The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at 9:00 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Al Bloemendaal, John Degen, Arlyn Kleinwolterink, Mark Sybesma and Dennis Wright.

11-02-22 2 Minutes of the meeting held on February 15, 2011, were submitted and the Chairman declared them approved.

11-02-22 3 Doug Julius, Sioux County Engineer

- Requested that the Board sign a permit agreement with Mutual Telephone Company of Sioux Center to bury fiber optic cable in various townships surrounding the city of Sioux Center. Motion by Wright and supported by Bloemendaal to approve and authorize the Chairman to sign the aforementioned permit agreement. Motion carried, unanimous in favor.
- Submitted a certification as to Completion of Work and Final Acceptance by the Board for Project No. BROS-CO84 (135)—5F-84 for a concrete slab bridge located on Garfield Avenue approximately 1 ½ miles north of B30, between Sections 11 and 12 of Plato Township. Motion by Kleinwolterink and supported by Degen to approve and authorize the Chairman to sign the aforementioned certification. Motion carried, unanimous in favor.

11-02-22 4 Coleman McAllister, Sioux County Attorney reported that he hopes to hire an assistant by the end of the week.

11-02-22 5 As this was the date and 9:30 a.m. the time set for a Public Hearing on an Iowa Department of Natural Resources Construction Permit Application for Myron Klarenbeek, proposing the construction of a swine nursery, in Section 13 of Settlers Township, the Chairman opened said hearing according to law. Suzanne Haverdink, Sioux County Zoning Assistant reviewed the application with the Board. No comments either written or oral were received. No one was present for this discussion. The Chairman closed the hearing. Motion by Bloemendaal and supported by Wright to recommend approval of the aforementioned permit to the Department of Natural Resources. Motion carried, unanimous in favor.

11-02-22 6 COMMITTEE REPORTS:

- **Sybesma**— a) Attended the Regional Airport Board meeting. Progress is being made in purchasing the property needed for the proposed airport. b) Reported that at a meeting of the Sioux County Foundation it was noted that charitable contributions will be awarded at the Sioux County Youth Fair for Lego building and quilting.
