- **08-03-11 1** The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at 9:30 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Dennis Wright, Vernon Beernink, Mark Sybesma, John Degen and Arlyn Kleinwolterink.
- **08-03-11 2** Minutes of the meeting held on March 4, 2008, were submitted and the Chairman declared them approved.
- **08-03-11 3** Randy Feenstra, County Treasurer submitted a resolution requesting suspension of taxes. Motion by Degen and supported by Wright to suspend taxes. Roll Call on Vote: Kleinwolterink, Yes; Degen, Yes; Beernink, Yes; Wright, Yes, and Sybesma, Yes. Motion carried, unanimous in favor.

## **08-03-11 4** Committee Reports:

- John Degen and Shane Walter, representing the Courtroom Restoration Committee, stated that the committee recommends that a Request for Proposal be prepared stipulating the quality and grade of carpet and a basic layout for the second floor carpeting project. A letter and RFP will be sent to all Sioux County carpet vendors.
- Wright and Sybesma Presented names of people that might be willing to serve on the Immigrant Task Force Committee. Sybesma stated that the committee should be carefully selected because it is important that this task force have credibility. It is the intent of the Board to provide a forum for dialog on this issue.
- Sybesma attended the Third Judicial District Meeting. Reported that the Third Judicial District is looking at a building project that would add 40 beds in Sioux City. Jeff Simonson was elected as president of that Board. Bylaws were revamped.

**08-03-11 5** Be it remembered that on the 11th day of March, 2008 at 10:00 o'clock a.m., the Board of Supervisors of Sioux County, met in session for the purpose of hearing on the budget estimate for Fiscal Year 2009, as filed with the Board. There was a quorum as required by law. Thereupon, the Board investigated and found that the notice and place of county budget hearing has according to law, and as directed by the Board, been published during the week of February 24, 2008 in the three official newspapers in said county, and that Affidavits of Publication thereof were on file with the County Auditor. Thereafter, and on said day the expenditures were taken up and considered and taxpayers heard for and against the same as follows:

## **08-03-11 8** Doug Julius, County Engineer

- Requested signatures from all members of the Board on the Title Sheet for Urban Renewal paving project near Sioux Center.
- Reported that the Hudson bridge replacement project is on schedule for completion late in the fall of 2009. The new bridge will be about 10 feet north of the old bridge.
- **08-03-11 9** Dan Altena, County Sheriff and Jake Anderson, Emergency Management Director presented a power point presentation explaining services provided by the Emergency Management Commission. Anderson stated that Ambulance service providers need to take ownership of the EMS association. The Board offered their support in the effort to involve Ambulance providers. The report was received for information. Beernink requested that Anderson investigate the procedure for bringing to a vote the addition of a 50 cent surcharge for E-911 services. This issue will need to be voted on in a County-wide Election. The next regular County-wide election will be held on November 3, 2008.

**08-03-11 10** Claims as submitted by the County Auditor were approved.

**08-03-11 11** The Chairman adjourned the meeting at 11:30 a.m. until Tuesday, March 25, 2008.
