MINUTES OF SIOUX COUNTY BOARD OF SUPERVISORS MEETING HELD ON MARCH 15, 2016

- **16-03-15 1** The Board of Supervisors of Sioux County, Iowa, met on Tuesday, March 15, 2016, at 9:00 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Al Bloemendaal, John Degen, Arlyn Kleinwolterink, Mark Sybesma and Dennis Wright.
- **16-03-15 2** Minutes of the meeting held on March 8, 2016, were submitted and the chairman declared them approved.
- 16-03-15 3 Shane Walter, Sioux County Zoning Administrator asked the Board to approve a Waiver of Separation of Distance for eight new chicken confinement buildings located at 2652 440th Street, Maurice. These buildings will replace existing chicken confinements. Motion by Degen and supported by Kleinwolterink to approve the requested separation of Distance. Motion carried, unanimous in favor.

16-3-15 Doug Julius, Sioux County Engineer

- Requested that the Board authorize the Chairman to sign a Contract with Hagedorn Construction for crushing, weighing and stockpiling gravel at Fairview, Groth and Keehn pits. Costs are \$2.00 a ton, for a total of approximately \$350,000. Motion by Wright and supported by Bloemendaal to approve and authorize the chairman to sign agreements with Hagedorn Construction for gravel crushing. Motion carried, unanimous in favor.
- Reported that there will be a re-letting for the bridge north of Rock Valley today. He may have results later today.
- 16-03-15 5 Orange City Fire Department representatives: John Heller, Dan Roghair and Dennis Vander Wel asked the Board for funding for the new Orange City Fire Station. Heller, president of Northwestern Bank in Orange City was the spokesman for the group. After viewing a power point presentation the Board was supportive of the request. The amount of financial support will be determined at a later meeting. Auditor Huitink was asked to research taking funding from the Rural Basic Fund.
- 16-03-15 6 As this was the date and 10:00 a.m. the time set for a Public Hearing to approve the FY 2015/2016 Budget, said hearing was opened by the chairman. Ryan Dokter, Sioux County Deputy Auditor presented the budget as published in the official county newspapers. John Degen spoke on behalf of the Conservation Board stating that there are some significant decreases in salaries for Conservation employees in the published budget. Sybesma: there are two issues 1) salary line items were adjusted to reflect a 2.5% increase, but other line items will cover the difference. Salaries as submitted by the Conservation Department will be paid according to the budget that Department submitted. 2) There is no money in budget for an additional naturalist position. Two Conservation Board members, Dave Meylink and Gordon Pottebaum were present for this discussion and stated that the Conservation Board will hire a naturalist and drop another position. Sybesma stated that if the Conservation Board hires a naturalist that action goes against the will of the Board of Supervisors. The Chairman closed the Public Hearing. Motion by Wright and supported by Bloemendaal to approve a resolution approving the budget and certifying taxes as submitted by the Auditor. Roll call on Vote:

Wright, Yes; Bloemendaal, Yes; Degen, No; Kleinwolterink, No; Sybesma, Yes. Motion carried three members in favor, two opposed due to lack of funding for second naturalist position.
