

MINUTES OF SIOUX COUNTY BOARD OF SUPERVISORS
MEETING HELD ON MARCH 18, 2014

14-03-18 1 The Board of Supervisors of Sioux County, Iowa, met on March 18, 2014, at 9:00 a.m. with Chairman Mark Sybesma presiding. Members present were Al Bloemendaal, John Degen, Arlyn Kleinwolterink, Mark Sybesma, and Dennis Wright.

14-03-18 2 Minutes of the meeting held on March 11 were submitted, and the Chairman declared the minutes approved.

14-03-18 3 Shane Walter, Sioux County Community Services Director, reported:

- That there are two items that have been placed on the Board Agenda for April 8. These items are preliminary to setting up an Urban Renewal District encompassing the Sioux County Regional Airport. Parcels owned by the Agency will be rezoned from Agricultural to Heavy Industrial and the County Zoning Ordinance will be amended to provide language addressing tall buildings in areas adjoining the airport.
- On March 27 the Planning and Zoning Board will meet and review the proposed changes to the Sioux County Zoning Ordinance.
- Board members will need to be appointed to serve on an Airport Board of Adjustment. McAllister advised the board to appoint some members to the Board who have aviation experience.

14-03-18 4 Doug Julius, Sioux County Engineer told the Board that:

- Road closure proceedings will begin for a portion of 460th Street East of the Sioux County Regional Airport.
- The 2014 Construction report will be given next week.
- A culvert letting is set for April 8 at 10:00 a.m.
- Tomorrow, March 19, is the first day of CPR training for secondary road employees.

COMMITTEE REPORTS

- **Wright** – a) Attended meetings in Des Moines with legislators and the Iowa Department of Human Services in regard to mental health funding. Wright reported that for the short term funding is adequate to provide services. b) There is a Regional Mental Health Governance Board meeting scheduled for this afternoon. c) Attended the ISAC spring school of instruction last week. **Bloemendaal, Kleinwolterink and Sybesma** also attended the meeting.
- **Bloemendaal and Sybesma** – Attended a Sioux County Regional Airport Board meeting yesterday. The only land left to purchase is on the west side of Highway 75. A fly-over will be done to map the topography of the airport. The DGR contract is for \$428,000 for work to be done this year.
- **Bloemendaal** - Attended a HIPAA presentation while at ISAC Spring School.
