

MINUTES OF SIOUX COUNTY BOARD OF SUPERVISORS
MEETING HELD ON APRIL 9, 2015

15-04-09 1 The Board of Supervisors of Sioux County, Iowa, met on April 9, 2015, at 9:00 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Al Bloemendaal, John Degen, Arlyn Kleinwolterink, Mark Sybesma and Dennis Wright.

15-04-09 2 Minutes of the meeting held on March 31, 2015 were submitted and the Chairman declared them approved.

15-04-09 3 Thomas Kunstle, Sioux County Attorney,

- Went to a Case Management Program with Laurie Bolluyt in Des Moines yesterday. Counties who subscribe to the Case Management Program are looking at streamlining its' administration to increase efficiency.
- Gave an update on land that the Conservation Department would like to lease. The South Dakota Railroad recognizes that they own the land. Rob Klocke is working with the railroad to work out a lease agreement with them.
- Reported that proposed legislation was introduced that would provide a statutory scheme for sentencing a juvenile who has committed a murder. Both the Iowa Senate and House of Representatives have laid out a new sentencing structure in these cases. Sentence options would be: life without parole; life with parole; or the possibility of parole after a predetermined time which is set by the judge.

15-04-09 4 Doug Julius, Sioux County Engineer

- Requested signatures on the following three title sheets:
 - a. L-4-2015—73-84-CULV (1/2 mile South of 340th Street on Jefferson Avenue)
 - b. L-6-2015—73-84-CULV (1/4 mile South of 390th Street on Dove Avenue)
 - c. L-7-2015—73-84-CULV (1/2 mile North of 390th Street on Larch Avenue)
- Permit agreements:
 - d. Trent Rehder – Run a water line from the North side of the NE ¼ of the NE ¼ Section 5 of Eagle Township to a new building.
 - e. Orange City Municipal Utilities – Run a 6" water line under 7th street NE (County Road - 440th Street, just West of Martin Drive.)
 - f. Orange City Municipal Utilities – Run water line to 4363 Jay Avenue along the East side of the SE ¼ and South side of the SE ¼ of the SE ¼ section 28 Holland Township to the Barbara De Jong home.

Motion by Kleinwolterink and supported by Degen to approve the aforementioned permit agreements. Motion carried, unanimous in favor.

- The contract that was awarded to Cedar Valley Corp of Waterloo Iowa, on March 31, 2015, has been signed by all parties and is finalized. A pre-construction meeting will be held on Monday, April 13, 2015. Work on K-52 will begin on April 14, 2015.

15-04-09 5 Committee Reports:

- **Kleinwolterink** – a) Attended an Employee Handbook Committee Meeting. b) Also attended a Northwest Iowa Regional Landfill meeting. Rulings on penalties being assessed, because of improper preparation of a new cell at the landfill, will be released this week.
- **Sybesma** – Motion by Kleinwolterink and supported by Degen to endorse the request by Orange City Area Health Systems to increase by 12 the number of beds at the Prairie Ridge Care Center. Motion carried, unanimous in favor. A letter of support was signed by the Chairman.
- **Wright** – a) Went to an Employee Handbook Committee Meeting b) Attended a Compass Pointe Board meeting where Kermit Dahlen, Jackson Recovery Center Director from Sioux City, shared with the board about the new youth recovery center that Jackson is building in Sioux City.

15-04-09 6 Ryan Dokter, Sioux County Deputy Auditor, requested that the Board give direction in regard to the purchase of Socrata software. The matter will be revisited in the next couple of years.

15-04-09 7 Aaron Haverdink, Sioux Rivers Services Coordinator – distributed the Sioux Rivers expenditure report for March.
