

**MINUTES OF SIOUX COUNTY BOARD OF SUPERVISORS**  
**MEETING HELD ON APRIL 10, 2007**

**07-04-10- 1** The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at 9:30 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Dennis Wright, Vernon Beernink, Mark Sybesma, John Degen and Arlyn Kleinwolverink.

**07-04-10- 2** Minutes of the meeting held on March 27, 2007, were submitted and the Chairman declared them approved.

**07-04-10- 3** Committee Reports

- From the early morning meeting of Leadership Team: GIS employee was discussed. Personnel Policy review, revision and implementation was encouraged. Communication and trust between county officials was discussed.
- Ergonomic review report given by John Degen.

**07-04-10- 4** Coleman McAllister, County Attorney, reported that today is the last day of employment for Loan Huynh. McAllister publicly expressed appreciation for the work Huynh has done for the County. The Chairman expressed thanks to Huynh on behalf of the citizens of Sioux County.

**07-04-10- 5** Motion by Kleinwolverink to adopt an Audio Tape Retention Policy. After discussion the motion was withdrawn and deferred to a later session.

**07-04-10- 6** Shane Walter, County Community Services Director, reported that the Zoning Ordinances on file are vague and are being revised.

**07-04-10- 7** Randy Feenstra, County Treasurer, informed the Board that two property tax suspensions have been requested for 2006/2007. A decision on suspension of taxes was tabled until the next meeting.

**07-04-10- 8** Ken Meendering, Orange City Code Enforcement Officer, addressed the Board on the involuntary annexation of nine parcels of property. Request for approval and the Chairman's signature on an Involuntary Annexation-Roadway Agreement. Motion by Kleinwolverink and supported by Wright to authorize the Chairman to sign a Roadway Agreement with the City of Orange City. Motion carried, unanimous in favor.

**07-04-10- 9** Doug Julius, County Engineer, requested approval of the following permit agreements:

- Rural Electric Coop – Set poles outside of fence line on County right of way in Section 23 of Garfield Township
- Hickory Tech – Install 25 pair telephone cable and one pedestal at 3177 350th street crossing 350th street 500' East of Harrison Avenue going west on south side of Harrison Avenue to 1200' west of Harrison Avenue crossing 350th Street then west on North side of 350th Street 4200' to Highway 75 in sections 9,10,15 & 16 of Welcome Township.

- Rural Water System #1 – Install water line crossing road at 380th & Goldfinch - once east to west, once north to south - 85 ft. from center of intersection in Sections 25 and 36 of Plato Township and Section 31 of Welcome Township.
- Southern Sioux Rural Water – Install a 2” PVC waterline crossing 510th Street .25 mile west of the mile line under the gravel road in section 32 of East Orange Township.

Motion by Beernink and supported by Degen to approve the aforementioned permit agreements. Motion carried, unanimous in favor.

**07-04-10- 10** Board member signatures were requested for the following Iowa Department of Transportation documents:

**07-04-10- 11** Motion by Beernink and supported by Degen to approve the Iowa DOT Secondary Road Budget for 2007/2008 and the five year construction plan as submitted by the County Engineer. Motion carried, unanimous in favor.

**07-04-10- 12** Motion by Wright and supported by Kleinwolterink to approve Salary Resolution No. 11 for 2007/2008. The roll was called and the vote was: Wright, Yes; Beernink, Yes; Degen, Yes; Kleinwolterink, Yes; and Sybesma Yes.
