

**MINUTES OF SIOUX COUNTY BOARD OF SUPERVISORS**  
**MEETING HELD ON APRIL 14, 2014**

**14-04-14 1** The Board of Supervisors of Sioux County, Iowa, met in the Courtroom of the Sioux County Courthouse on April 14, 2014, at 9:00 a.m. with Chairman Mark Sybesma presiding. Members present were Al Bloemendaal, John Degen, Arlyn Kleinwolterink, Mark Sybesma, and Dennis Wright.

**14-04-14 2** Motion by Degen and supported by Wright to appoint Thomas Kunstle to the position of interim Sioux County Attorney until the General Election to be held on November 4, 2014. Motion carried unanimous in favor. Judge Jeffrey Neary then administered the oath of office to Kunstle.

**14-04-14 3** The meeting was then moved to the Board of Supervisors Room where minutes of the meeting held on April 8 were submitted, and the Chairman declared them approved.

**14-04-14 4** Shane Walter, Sioux County Community Services Director, informed the Board that the last Sioux Rivers Regional Mental Health meeting included a request for new core services designed for our region. Other discussion included implementation of crisis management prior to commitments.

**14-04-14 5** Motion by Wright and supported by Bloemendaal to approve a 28E Agreement with the counties of Cherokee, Plymouth, and Woodbury to form the Sioux Rivers Mental Health Region. Motion carried, unanimous in favor. The other counties also plan to sign the agreement this week. It will be forwarded to the Department of Human Services for their approval next week.

**14-04-14 6** Doug Julius, Sioux County Engineer

- Reported that road crews have been blading and graveling county roads. Dust control has been requested by several parties. Dust control may be applied between May 1 and October 1.
- Culvert bids that were presented last week have been verified.
- Told the Board that no response was received in regard to the purchase of right-of-way near Trans-Ova Genetics. He is proceeding with condemnation proceedings in regard to the 1.6 acres in question.

**14-04-14 7** COMMITTEE REPORTS:

- **Wright** – a) Reported on a Regional Mental Health meeting. A meeting was held with Mental Health providers. The goal is to provide services for residents at cost. b) Attended a Foster Grandparent banquet with **Kleinwolterink** in Rock Valley. Reported that the organization has hired a new director. c) Attended an Executive Board Meeting to discuss financial issues at the YES Center.
- Kleinwolterink attended a Northwest Iowa Regional Landfill meeting.
