

MINUTES OF SIOUX COUNTY BOARD OF SUPERVISORS
MEETING HELD ON APRIL 22, 2008

08-04-22 1 The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at 9:30 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Dennis Wright, Vernon Beernink, Mark Sybesma, and Arlyn Kleinwolterink. Absent from this meeting was Supervisor John Degen.

08-04-22 2 Minutes of the meetings held on April 15 and April 17, 2008, were submitted and the Chairman declared them approved.

08-04-22 3 Coleman McAllister, County Attorney

- Reported that a brother of the gentleman whose body was recently discovered in Sheldon has been located in Japan. The brother called McAllister this morning and shared that he is very appreciative of the military funeral that was arranged by Sioux County for his brother.
