The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at

9:30 o'clock A.M. with Chairman Loren Bouma presiding. Members present were

Committee reports were given this date.

Motion by Vander Maten and supported by De Haan to approve and authorize the

Chairman to sign the following Inter-fund Operating Transfer Resolution:

WHEREAS, it is desired to make the following inter-fund operating transfer:

\$50,000 from General Basic to General Supplemental Fund

WHEREAS, said operating transfer is made in accordance with Section 331.432, 1998

Section 1. The following inter-fund operating transfer is made effective May 11, 1999,

\$50,000 from General Basic Fund to General Supplemental Fund

this resolution and the record of its adoption.

Motion by Beernink and supported by De Haan to approve and authorize the Chairman to sign a certificate appointing the required number of real estate owners in townships, real estate owners in cities, real estate brokers and bankers in Sioux County to serve on the Condemnation Board for Eminent Domain in compliance with Section 6B.4, 1998 Iowa Code, as shown on file in the County Auditor's Office. Carried, unanimous in favor

Mark Schouten, County Attorney, met with the Board this date to update them on the Courtroom video grant project. He also reported on federal regulations pertaining to the awarding and payment of accumulated compensatory time over 240 hours under the Fair Labor Standards Act. He further stated that Sioux County's personnel policy needs to be revised to reflect current federal regulations pertaining to the awarding and payment of accumulated compensatory time. Governmental entities may opt to pay overtime instead of awarding compensatory time.

The consensus of the Board pertaining to the aforementioned compensatory time issue was to explore the idea of paying overtime to non-exempt county employees instead of awarding compensatory time and to rectify the underpayment issue of compensatory time over 240 hours with any applicable employees.

Motion by Beernink and supported by De Haan to go into executive session according Section 21.5(1g), 1998 Iowa Code, upon the recommendation of Mark Schouten, County Attorney, to avoid disclosure of specific law enforcement matters, such as current or proposed investigations, inspection or auditing techniques or schedules,

Mark Dunlop, County Zoning Administrator and Emergency Management

Services Director, met with the Board this date to report that the current ambulance and
emergency rescue vehicle replacement plan will expire on October 1, 2001. He stated
that the Board needs to address the funding mechanism for any new ambulance and
emergency rescue vehicle replacement plan to be implemented effective October 1, 2001.

Robert Hagey, County Treasurer; Anita Van Bruggen, County Recorder; and Dennis Lange, County Auditor, met with the Board to present and discuss a proposed clerical salary schedule that would be based on a percentage of the average salary of the County Auditor, Recorder and Treasurer. The percentage would be based on education and number of years of experience. Wage comparison figures for local banks, Orange City Clerk's office and surrounding counties were discussed.

The consensus of the Board was to instruct Robert Hagey, County Treasurer, to obtain wage verification from local banks before making a final decision on the proposed clerical wage schedule. The Board will set salaries for all clerical, custodial and appointed county employees at the next meeting to be held on May 25, 1999.

Shane Walter, County Central Point of Coordination Administrator, met with the Board this date to review the contents of the Sioux County MH/DD Management Plan for fiscal year 2000. He also requested approval and a Chairman's signature on a form designating Plains Area Mental Health Center as Sioux County's community health center affiliate provider.

Motion by Smith and supported by Vander Maten to approve and authorize the Chairman to sign a form designating Plains Area Mental Health Center as Sioux County's community health center affiliate provider. Carried, unanimous in favor.

Motion by Vander Maten and supported by Beernink to approve and authorize the Chairman to sign an agreement with New Life Treatment Center regarding court referred clients for chemical dependency treatment. Carried, unanimous in favor.
