

MINUTES OF SIOUX COUNTY BOARD OF SUPERVISORS

MEETING HELD ON JUNE 5, 2006

The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at 8:30 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Loren Bouma, Vernon Beernink, Mark Sybesma, John Degen and Stanley L. De Haan.

It was with regret that the Board accepted the resignation of long time Sioux County Auditor Dennis D. Lange effective May 31, 2006.

Motion by Beernink and supported by De Haan to accept the resignation of Dennis Lange as Sioux County Auditor. Motion carried, unanimous in favor.

Motion by De Haan and supported by Degen to provide a severance package for Lange equal to an amount that would have been paid to him for FY05/06. The county will also reimburse Lange for the amount of family health insurance premiums to the end of his term or as long as family health insurance is required.

Motion by Bouma and supported by Beernink to pass the following Resolution recognizing Dennis Lange's service to the citizens of Sioux County.
