

MINUTES OF SIOUX COUNTY BOARD OF SUPERVISORS

MEETING HELD ON AUGUST 27, 2008

- 08-08-27 1** The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at 10:00 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Dennis Wright, Vernon Beernink, Mark Sybesma, and Arlyn Kleinwolterink. Member John Degen was not present for this meeting.
- 08-08-27 2** Minutes of the meeting held on August 19, 2008, were submitted and the Chairman declared them approved.
- 08-08-27 3** Jake Anderson, Emergency Services Director presented information on an issue that will be placed on the ballot for the General Election to be held on November 4, 2008. Voters will be asked to approve an increase in the E-911 service charge from \$.50 to \$1.00. Report received for information.
- 08-08-27 4** Doug Julius requested and was granted permission to present an update to the Board on ongoing construction projects.
- 08-08-27 5** Motion by Wright and supported by Kleinwolterink to approve a resolution to place on the ballot for the General Election to be held on November 4, 2008, a question that would allow vacancies to be filled by appointment to the office of Township Clerk and Trustee for Logan and Buncombe Townships. Roll Call on Vote: Kleinwolterink, Yes; Wright, Yes; Beernink, Yes; and Sybesma, Yes. Motion passed unanimous in favor, one member absent.

RESOLUTION 2008-20

To Place Clerk/Trustee Question on the General Election Ballot

WHEREAS, it is frequently difficult to fill the position of Township Trustees and Clerk at the general election; and

WHEREAS, the Iowa Legislature has amended Iowa Code Section 39.22 to permit the Board of Supervisors to fill the offices of Township Trustee and Clerk by appointment; and

WHEREAS, the County Commissioner of Elections is to submit the question to the eligible voters of Buncombe and Logan Townships at the next general election;

NOW, THEREFORE, BE IT RESOLVED by the Supervisors of Sioux County that the Sioux County Commissioner of Elections is hereby directed to submit the question whether the offices of Trustee and Clerk in Buncombe and Logan Townships shall be filled by appointment by the Board of Supervisors, to the eligible voters of those Townships at the next general election which form would be substantially as follows:
