

**MINUTES OF SIOUX COUNTY BOARD OF SUPERVISORS**  
**MEETING HELD ON SEPTEMBER 12, 2008**

**08-09-12 1** The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at 9:00 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Dennis Wright, Vernon Beernink, Mark Sybesma and John Degen. Member Arlyn Kleinwolterink was absent.

**08-09-12 2** Minutes of the meeting held on September 2, 2008, were submitted and the Chairman declared them approved.

**08-09-12 3** Coleman McAllister, County Attorney stated that a transfer deed has been prepared for the transfer of Sioux County property to Patricia Dennison. This property contains abandoned sand pits in Sherman Township Section 20. Motion by Degen and supported by Wright to approve the transfer of the aforementioned property. Motion carried, unanimous in favor, one member absent.

**08-09-12 4** Lisa Rowenhorst, Election Administrator met with the Board to present results of the School Election held on September 9, 2008. Motion by Wright and supported by Beernink to approve the Canvass of School Election Returns. Motion carried, unanimous in favor, one member absent.

**08-09-12 5** Committee Reports

- Sybesma distributed the third judicial table of organization, chart of offenders by county, and a budget report. Reported that the state is considering building a new facility in Woodbury County.
- Wright reported that the Immigration Focus group held a sixth session on September 10. A presentation will be made to the Board of Supervisors in the near future.

**08-09-12 6** Doug Julius, County Engineer

A. Requested Board approval of the following permits:

- **Mid American Energy** – Install 6” plastic gas main on the east side of Hickory Avenue near Hull in Lincoln Township.
- **Southern Sioux Rural Water** – Bore 2” PVC waterline in Sections 3 and 10 of Washington Township.
- **Southern Sioux Rural Water** – Bore 1 1/2” PVC waterline in Sections 27 and 28 of Eagle Township.
- **Southern Sioux Rural Water** – Bore 1 1/2” PVC waterline in Sections 34 and 35 of Washington Township.

Motion by Beernink and supported by Degen to approve permits as submitted by the County Engineer. Motion carried, unanimous in favor, one member absent.

B. Requested that the Chairman sign a change of ownership document for property near Chatsworth for use by the Sioux County Agriculture Extension Office.

C. Submitted a proposal for fall spraying of leafy spurge – received for information.

D. Reported on the progress of road construction projects.
