

**MINUTES OF SIOUX COUNTY BOARD OF SUPERVISORS**  
**MEETING HELD ON OCTOBER 27, 2015**

**10-27-15 1** The Board of Supervisors of Sioux County, Iowa, met on October 27, 2015, at 9:00 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Al Bloemendaal, John Degen, Arlyn Kleinwolverink, Mark Sybesma and Dennis Wright.

**10-27-15 2** Minutes of the meeting held on October 20, 2015 were submitted and the Chairman declared them approved.

**10-27-15** Thomas Kunstle, Sioux County Attorney

- Told the Board that on October 14, 2015 a law enforcement training event was held. Eighty individuals attended this event. Kunstle reported that attendees were very appreciative of this opportunity.
- Gave a presentation to Unity Christian High School students this morning.

**10-27-15 5** Micah Van Maanen, Sioux County IT, Administrator told the Board that a County equipment auction will be held beginning on November 2 and will run through November 16.
