

MINUTES OF SIOUX COUNTY BOARD OF SUPERVISORS
MEETING HELD ON DECEMBER 2, 2008

08-12-02 1 The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at 9:30 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Dennis Wright, Vernon Beernink, Mark Sybesma, Arlyn Kleinwolterink and John Degen.

08-12-02 2 Minutes of the meeting held on November 25, 2008, were submitted and the Chairman declared them approved.

08-12-02 3 Coleman McAllister, County Attorney informed the Board that the amount of grant money received from the State of Iowa for victim's assistance will likely be cut.

08-12-02 4 Shane Walter, Community Services Director:

- Mental Health: Presented the October 2008 Monthly MH/DD Service Expenditure Report.
- Zoning: Reminded the Board that the Master Matrix Plan for 2009 will need to be approved in January.
- Zoning: Will want to discuss home occupations in the future.

08-12-02 5 Sioux County Library Association representatives, Phyllis Uittenbogaard, Matt Hoehamer, Cheryl Hoekstra, Shari Fedders, Hope Hofland, Valerie Haverhals, Karla Chase and Lorna Van Maanen were present to make a request for library funding for Fiscal Year 2009/2010. The request presented was for a 4% increase over the amount given for Fiscal Year 2008/2009. Several new services are available at each library. Wilbur is a new service that allows patrons of the library to download audio books. Funding from Bill Gates to Put Libraries on the Web (PLOW) has enabled each of the libraries to have a site on the World Wide Web. The Board will consider the request during budget discussions.

08-12-02 6 George Rehder has announced that he is no longer willing to serve as the Board's representative on the Compensation Board. The Supervisors will appoint a member to serve on their behalf on the Compensation Board.

08-12-02 7 Committee Reports

- Wright stated that he will be meeting with mental health providers this month.
- Sybesma reported that federal funding for a regional airport will, at the earliest, be available in October 2009.

08-12-02 8 Motion by Degen and supported by Wright to approve two permit agreements as submitted by the County Engineer:

- Dan Waterman – Bore 1 1/2" PVC line under 460th Street between Sections 1 and 12 of Logan Township.
- Northwest REC – Install poles just outside the fence line on the County right-of-way in Section 28 of Center Township.
