MINUTES OF SIOUX COUNTY BOARD OF SUPERVISORS MEETING HELD ON OCTOBER 30, 2018

- 1) The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at 9:00 a.m. with Chairman Sybesma presiding. Members present were John Degen, Mark Sybesma, Dennis Wright, Al Bloemendaal and Arlyn Kleinwolterink.
- 2) Minutes of the meeting held on October 16, 2018, were submitted, and the Chairman declared them approved.
- 3) Claims were approved for October 30, 2018 as submitted by the County Auditor.
- 4) Ryan Dokter, Sioux County Auditor, informed the Board that in order to continue the process for the Nature Center funding, that the Conservation Reserve/Land Acquisition Fund needs to be formally approved by the Board, per Iowa Code 350.6. This fund was established as far back as 1998, but there was no motion or resolution recorded in the minutes. Motion by Degen and supported by Bloemendaal to approve a Conservation Reserve/Land Acquisition Fund per Iowa Code 350.6. Motion carried unanimously.
- 5) Ryan Dokter, Sioux County Auditor, proposed the following resolution for Board consideration. Motion by Kleinwolterink, and supported by Wright to approve the resolution. RESOLUTION FIXING DATE FOR A MEETING TO DISCUSS THE PROPOSITION OF ENTERING INTO A LOAN AGREEMENT AND THE ISSUANCE OF NOT TO EXCEED \$1,850,000 GENERAL FUND CAPITAL LOAN NOTES TO EVIDENCE THE OBLIGATIONS OF THE COUNTY THEREUNDER AND PROVIDING FOR PUBLICATION OF NOTICE THEREOF.

WHEREAS, it is deemed necessary and advisable that the County of Sioux, State of Iowa, should enter into a Loan Agreement and issue General Fund Capital Loan Notes in the principal amount of not to exceed \$1,850,000, as authorized by Section 331.402(3)(d)(2), Code of Iowa, as amended, for the purpose of paying costs of constructing and equipping a Nature Center; and

WHEREAS, said Notes shall be payable from the General Fund of the County and, being in excess of the small issue exception, require a public meeting and hearing process, pursuant to Section 331.402(3)(d)(2), Code of Iowa; and

WHEREAS, it is necessary to publish a notice of the proposal and of the time and place of the meeting at which the Board proposes to discuss the proposal of entering into a Loan Agreement and the issuance of General Fund Capital Loan Notes for the above-mentioned purpose, in the amount of not to exceed \$1,850,000.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF SIOUX, STATE OF IOWA:

Section 1. That this Board meet in the Board of Supervisor's Room, County Courthouse, 210 Central Avenue Southwest, Orange City, Iowa, at 2:45 P.M., on the 14th day of November, 2018, for the purpose of discussing the proposal of entering into a Loan Agreement and the issuance of General Fund Capital Loan Notes for the abovementioned purpose, in the amount of not to exceed \$1,850,000.

Section 2. That the Auditor is hereby directed to cause at least one publication to be made of a notice of said meeting, in a legal newspaper, printed wholly in the English language, published at least once weekly, and having general circulation in said County, said publication to be not less than ten (10) clear days before the date of said public meeting to discuss said proposal.

Section 3. That should the Board proceed with the agreement and issuance, a public meeting be held on the 18th day of December, 2018, at 9:30 A.M., being not less than 30 days from the discussion meeting, to take additional action.

Section 4. The notice of the proposed action shall be in substantially the following form:

RESOLUTION RECOMMENDING APPROVAL OF LYON COUNTY'S REQUEST TO JOIN THE SIOUX RIVERS REGIONAL MHDS REGION EFFECTIVE JULY 1, 2019

WHEREAS, the Sioux County Board of Supervisors has reviewed the Sioux Rivers Regional MHDS Governance Board's recommendation of 10/23/18 for approval for Lyon County to enter into partnership with the Sioux Rivers Regional MHDS Region; and

WHEREAS, Lyon County, by their vote of 10/22/18, has formalized their intention to join the Sioux Rivers Regional MHDS Region by entering into a 28E Agreement; and

WHEREAS, Lyon County, by said same vote, has expressed a willingness to accept the terms and conditions of the 28E Agreement, which requires a financial contribution and a per capita payment to the Sioux Rivers Regional MHDS based upon the terms of the 28E agreement; and

WHEREAS, Lyon County, by said same vote, has expressed a willingness to accept the terms and conditions of the Regional MHDS Management Plan, as approved by the Sioux Rivers Regional Governance Board and the Department of Human Services; and

WHEREAS, the Sioux Rivers Regional MHDS Governance Board has passed a motion to allow Lyon County to enter the Region effective July 1, 2019 should the majority of the member Counties approve a Resolution of the same;

NOW, THEREFORE, BE IT RESOLVED that the Sioux County Board of Supervisors hereby approves the request of the Lyon County Board of Supervisors to join the Sioux Rivers Regional MHDS. SO DATED this 30th day of October 2018.

 - 26 new desktop computers have been purchased and reported that the costs have gone up due to the tariffs with China. Originally this project was going to be spread over two fiscal years, and proposed that this purchase be made sooner than later to save money. Costs continue to increase 5% or more every month. Van Maanen will obtain quotes and present those to the Board and may require a budget amendment.
- 11) Nate Huizenga, Sioux County Emergency Management Director, and Cara Elbert, Northwest Iowa Planning and Development requested Board approval of a resolution adding Osceola County to the Hazard Mitigation grant. The State will not approve a grant to a single county, which prompted the addition of Osceola County. If approved, this grant will be \$10,000 for each county, with the county's each matching that \$10,000. \$5,000 match in FY2020 and \$5,000 match in FY2021.
