- 14-01-28 1 The Board of Supervisors of Sioux County, Iowa, met on January 28, 2014, at 9:00 a.m. with Chairman Mark Sybesma presiding. Members present were Al Bloemendaal, John Degen, Arlyn Kleinwolterink, Mark Sybesma, and Dennis Wright.
- **14-01-28 2** Minutes of the meeting held on January 21, 2014, were submitted, and the Chairman declared the minutes approved.
- **14-01-28 3** Recommendations of the Compensation Board were reviewed. A decision will be made at a later meeting
- 14-01-28 4 Discussed the Fiscal Agent Agreement with Early Childhood Development. An option to fulfill the contract until the end of the fiscal year and then decline to provide service for next fiscal year was suggested. Input will be requested from the County Attorney. Coleman McAllister, County Attorney, joined the meeting after finishing a Court case. McAllister stated that he will inform the Early Childhood Development Board of the County's intent to act as Fiscal Agent through June 30, 2014.
- **14-01-28 5** Coleman McAllister reported that yesterday there were eight pleas filed on felony cases. Five cases were on the Court Calendar for today.
- **14-01-28 6** Randy Jacobsma, Sioux County Treasurer

14-01-28 7 Shane Walter, Sioux County Community Services Director

- Told the Board the Regional Mental Health Board met last week and will likely appoint a Fiscal Agent at their next meeting. The Board will need to appoint officers in the near future.
- Noted that The Creative Living Center agreement needs to be reviewed. Each person served by that agency has been sent a letter informing them that they will need to have insurance coverage, as mandated by the Affordable Care Act.

- 14-01-28 8 Arlo Van Beek, President of the Sioux County Historical Society asked the Board to support the work of the Society in Fiscal Year 2014/2015. He reported that a web site has been added; they have expanded the veteran's room, and hope to build a blacksmith shop display. The Society is asking for support for their program. Van Beek is currently cataloging the inventory. This information will be put on the website. The Historical Society needs to purchase a computer and obtain internet access for this project. Micah Van Maanen, Sioux County's IT director told him that they should be able to access the County's Public web site. Additional help to choose proper equipment was offered by Van Maanen. A request to help with the cost for a computer and printer (\$6,000) was submitted.
- 14-01-28 9 John Slegers presented a budget request for NISO (Northwest Iowa Symphony Orchestra). Slegers thanked the Board for its past support. A letter from Jim Koldenhoven, NISO Board member asked for \$2,000 in support for Fiscal Year 2014/2015. Slegers noted that a separate concert for children was added this year. Musicians include all ages from eighth grade to retirement will participate in a Pops Concert this week Saturday.
- **14-01-28 10** Doug Julius, Sioux County Engineer presented three Certifications as to Completion of Work and Final Acceptance documents for Board approval. Motion by Wright and supported by Bloemendaal to authorize the Chairman to sign these documents for projects: L-8-2010—73-84-CULV, L-2-2010—73-84-CULV, and L-6-2011—73-84-CULV. Julius reported that equipment maintenance and servicing have been done during the cold weather.
