

**MINUTES OF SIOUX COUNTY BOARD OF SUPERVISORS**  
**MEETING HELD ON APRIL 2, 2013**

**13-04-02 1** The Board of Supervisors of Sioux County, Iowa, met on April 2, 2013, at 9:00 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Al Bloemendaal, John Degen, Arlyn Kleinwolterink, Mark Sybesma and Dennis Wright.

**13-04-02 2** Minutes of the meeting held on March 26, 2013, were submitted and the Chairman declared them approved.

**13-04-02 3** Coleman McAllister, Sioux County Attorney informed the Board that a Facebook page has been set up for the Sioux County Attorney.

**13-04-02 4** Health insurance coverage for next year was discussed. Sybesma will check with Harvey Wiltsey, the County's labor negotiator, to determine if the County would be able to change to a different prescription plan.

**13-04-02 5** Shane Walter, Sioux County Community Services Director requested the Board's approval and the Chairman's signature on an agreement between the Department of Human Services and Sioux County to enable the County to receive Mental Health and Disability Services Redesign Transition Funds. The amount that the County will receive is \$1,817.00. Motion by Wright and supported by Degen to approve an agreement with DHS as presented. Motion carried, unanimous in favor.

**13-04-02 6** Doug Julius, Sioux County Engineer

- Distributed a tabulation sheet for four asphalt paving projects. This will involve projects on B30 and B40. The contracts for these projects should be available for approval in the next few weeks.
- Asked the Board to sign a resolution to reduce the speed limit on B40 on the east side of Sioux Center. The Sioux Center City Council has already approved this change. Motion by Bloemendaal and supported by Wright to approve reducing the speed limit on B40 east of Sioux Center. Roll call on vote: Kleinwolterink, Yes; Degen, Yes; Bloemendaal, Yes; Wright, Yes; and Sybesma Yes. Motion carried, unanimous in favor.

**SIOUX COUNTY RESOLUTION NO.: 2013-09**

**CITY OF SIOUX CENTER RESOLUTION NO.: SC-R-09-13**

**WHEREAS:** The Board of Supervisors of Sioux County are empowered under authority of Section 321.255 and 321.285 of the Code of Iowa to determine that the Speed Limit on any secondary road/extension is greater than is reasonable and proper under the conditions existing, and may determine and declare a reasonable and proper speed limit, and

**WHEREAS:** Sioux County, Iowa has jurisdiction over 400<sup>th</sup> Street (B40) along the south side of Section 3, T95N, R45W (West Branch Twp) east of the Corporate Limits of Sioux Center, Iowa and has concurrent jurisdiction with Sioux Center, Iowa over the extension of 400<sup>th</sup> Street

(B40)/9<sup>th</sup> Street S.E. within the Corporate Limits of Sioux Center, Iowa along the south side of Section 4, T95N, R45W (West Branch Twp), and

**WHEREAS:** The City of Sioux Center, Iowa has requested that a reasonable and proper Speed Limit be established for the safety of pedestrians, children, and the traveling public near and in the area of a new hospital complex and residential areas.

**NOW THEREFORE BE IT RESOLVED** by the Sioux County Board of Supervisors and the City of Sioux Center, Iowa that the 40 M.P.H. Speed Limit on 400<sup>th</sup> Street (B40)/9<sup>th</sup> Street S.E. within the Corporate Limits of Sioux Center as established in Sioux County Resolution No: 2011-24 and City of Sioux Center Resolution No.: SC-R-22-11 be extended to the east as follows:

- 1) To re-establish and extend an additional 2,200 feet to the east the existing 40 M.P.H Speed Limit Zone. Beginning approximately 1,110 feet east and ending approximately 4,450 feet east of the intersection of 4<sup>th</sup> Avenue and (B40)/9<sup>th</sup> Street S.E. within the Corporate Limits of Sioux Center, Iowa and rural Sioux County, Iowa.

- **Sybesma** – a) Attended a Regional Housing Trust Fund meeting. He reported that money left over from 2011 needs to be spent before 2013 funds can be used. It was decided to give Habitat for Humanity and the Family Crisis Center \$15,000 each because of this. Sybesma requested that the reporters present might run articles about this agency. b) Met with a new organization The Flying Dutchmen.

- **Wright** – Attended a Compass Pointe meeting. Discussion was held in regard to appointing a recovering alcoholic to the Board. Motion to appoint Paul Walton to the Compass Pointe Board to represent Sioux County, replacing Mark Sybesma on that Board. Sybesma would be the alternate. Motion carried, unanimous in favor. Officers for that organization have been changed. Dennis Wright is now the Chairman of the Compass Pointe Board.

**13-04-02 8** Claims as submitted by the Auditor were approved for payment.

**13-04-02 9** The meeting was adjourned at 10:50 a.m. The next meeting will be held on April 16, 2013, beginning at 9:00 a.m.
