MINUTES OF SIOUX COUNTY BOARD OF SUPERVISORS MEETING HELD ON APRIL 20, 2010

- 10-04 20 1 The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at 9:00 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were John Degen, Arlyn Kleinwolterink, Mark Sybesma, Al Bloemendaal and Dennis Wright.
- **10-04 20 2** Minutes of the meeting held on April 6, 2010, were submitted and the Chairman declared them approved.
- 10-04 20 3 Coleman McAllister, Sioux County Attorney reported that a township clerk has failed to file reports as required by law. Because the Orange City, Maurice and Sioux Center Fire Departments depend on financial support from this township, discussion was held on further action to be taken. NOTE: The annual report was received from the township clerk during the meeting. No further action will be taken.
- **10-04 20 4** Anita Van Bruggen, Sioux County Recorder presented the Recorder's Quarterly Report. It was received for information.
- 10-04 20 5 Shane Walter, Sioux County Community Services Director and Aaron Haverdink, Assistant Community Services Director met with the Board. Walter requested approval and the Chairman's signature on an Iowa Department of Public Health County Substance Abuse Prevention Services Request for Bid for Fiscal Year 2011. Motion by Wright and supported by Bloemendaal to approve and authorize the Chairman to sign the aforementioned document. Motion carried, unanimous in favor. Haverdink shared two success stories from citizens who received general assistance. A book by author Dave Ramsey entitled *Total Money Makeover* has been purchased and given to certain individuals applying for general assistance. This book and one-on-one counseling have been shown to be helpful in giving support to those with financial need.
- 10-04 20 6 As this was the date and 9:45 a.m. the time set for a Public Hearing to review a construction permit application for the construction of a dairy confinement feeding operation structure, said hearing was opened by the Chairman and held according to law. Shane Walter, Zoning Administrator presented a construction permit request from M&M Dairy. The request was for the construction of a 24-inch waste flume pipe, a concrete reception pit and an earthen manure storage basin (280 animal units) to be built in Lincoln Township Section 21. No written or verbal comments were received regarding this project. The Public Hearing was closed by the Chairman. A favorable letter of recommendation will be forwarded to the DNR for this project. Motion carried, unanimous in favor.

10-04 20 7 Doug Julius, Sioux County Engineer

- Submitted the following permit agreement for Board approval and the Chairman's signature:
 - ➤ Margit Kock Run tile line in ditch in Section 29 of Sioux Township (SE corner of the S 1/2 of the SW 1/4).

Motion by Degen and supported by Kleinwolterink to approve and authorize the Chairman to sign the aforementioned permit agreement. Motion carried, unanimous in favor.

Requested that the Board sign a joint resolution with Plymouth County to place stop signs at the intersection of Garfield Avenue and 510th Street in Sioux County. Motion by Degen and supported by Kleinwolterink to approve a joint resolution with Plymouth County to place stop signs at the east and north entrance of the intersection of Garfield Avenue and 510th Streets. . PLYMOUTH COUNTY RESOLUTION NO.

- WHEREAS: The Sioux County Board of Supervisors and Plymouth County Board of Supervisors are empowered under authority of Sections 321.236, 321.255 of the Code of Iowa to designate any secondary road intersection under their jurisdiction as a STOP intersection and to erect STOP signs at one or more entrances to such intersections, and
- WHEREAS: The intersection of Garfield Avenue and 510^h Street at the SW Corner Section 36, T94N, R44W Sioux County, Iowa and common to the intersection of Kestrel Avenue and 100th Street at the NW Corner Section 1, T93N, R46W Plymouth County, Iowa functionally classified as local Area Service and presently does not have legally established **STOP** approaches at the east and north entrance(s) to the intersection, and
- WHEREAS: The placing of legally established STOP approaches at the east and north entrance(s) to the intersection would further enhance the safety and welfare of the traveling public because of terrain and building site which limit sight distance,

NOW THEREFORE BE IT RESOLVED by the Sioux County Board of Supervisors and the Plymouth County Board of Supervisors that the Area Service road approaches from the east and north be designated as "STOP APPROACHES" to the described intersection and that STOP signs shall be erected accordingly.
