

MINUTES OF SIOUX COUNTY BOARD OF SUPERVISORS

MEETING HELD ON MAY 7, 2001

The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at 9:00 o'clock a.m. with Chairman Loren Bouma presiding. Members present were Mark Sybesma, Vernon Beernink, Loren Bouma, Bernard L. Smith and Stanley L. De Haan.

Minutes of May 1, 2001 were read and on motion and vote stand approved as read.

Committee reports were given this date.

Dennis Lange, County Auditor, reported on the canvass of election returns for the Special Sioux Center Community School District Election held on Tuesday, May 1, 2001.

Motion by Beernink and supported by Sybesma to approve the following canvass of the Special Sioux Center Community School District Election returns including special and late absentee ballots that were received and properly postmarked after the polls closed in accordance with Section 53.17, Code of Iowa:

SHALL THE FOLLOWING PUBLIC MEASURE BE ADOPTED?

“Shall the Board of Directors of the Sioux Center Community School District in the County of Sioux, State of Iowa, be authorized to contract indebtedness and issue General Obligation Bonds in the amount not to exceed \$2,275,000 to provide funds to build and furnish an All Seasons Recreation Center building?”

Yes 1,443 No 430

The public measure was approved due to the required 60% passage requirement.

Carried, unanimous in favor.

Motion by De Haan and supported by Beernink to approve a revised Lease Agreement with the Iowa Department of Human Services for space occupied in the County Department of Human Services/Public Health Facility to deliver Case Managements for the period from July 1, 2001 to June 30, 2004. Carried, unanimous in favor.

The Board discussed whether it was necessary to further promote economic development at the county level. They acknowledged that most cities have hired economic development directors to promote economic development programs in their respective cities. Originally, the Board implemented the Sioux County Economic Development Loan Fund Program to offer low interest loans as an incentive for companies to create new jobs. No decision was reached about further promoting economic development at the county level.

The Board discussed the appointment of four republican persons to serve on the seven member Temporary Sioux County Redistricting Commission.

Motion by Beernink and supported by De Haan to appoint the following four republican persons to serve on the seven member Temporary County Redistricting Commission:

Carried, unanimous in favor.

Loren Bouma, Chairman of Board, stated that John O'Brien, Chairman of the Sioux County Democratic Party has appointed Dallas Huebner, Pat Kusters and Francis

Brooke to serve as three Democratic persons to serve on the seven member Temporary Sioux County Redistricting Commission.
