09-11-10 5 Micah Van Maanen, Sioux County IT Director reported that some computer equipment was moved to the Public Safety Center last weekend. He also reported that in the city election on November 3 some social networking tools were utilized. An update to Windows 7 will probably be initiated early next year.

09-11-10 6 As this is the date and 9:45 o'clock a.m. the time for the consultation hearing to be held between Sioux County, Iowa and all affected taxing entities concerning the proposed Sioux County Urban Renewal District 1 Urban Renewal Plan Amendment #2, said consultation hearing was held. Designated Representative Mark Sybesma, Chairman of Board of Supervisors conducted the consultation hearing. No one was present to give comment on the proposed amendment to Sioux County Urban Renewal Area 1. No written comments were received by the County Auditor. The Chairman closed the hearing.

09-11-10 7 Committee Reports:

- **Sybesma** – A grant to the Northwest Iowa Regional Housing Trust Fund Inc. was approved. It is anticipated that funding will be received in January 2010.

09-11-10 8 Claims as submitted by the County Auditor were approved.
