- Healthy Families program has had 12 referrals since August 1
- Regionalization of Healthy Families is being discussed by the Northwest Iowa Early Childhood Board to contain costs
- Promoting healthy behaviors and were awarded a De-Cat mini grant for family literacy programs to help parents and children gain literacy skills
- Health improvement planning groups for daycare and housing

- Other activities are ongoing treatment of active TB case, sun safety grant from Iowa CA Consortium, passport event held in Sioux Center, meeting with Senator Feenstra, ALICE training with DHS, and the new vaccine requirement for 7<sup>th</sup> and 12<sup>th</sup> grade students
- Reviewed the new emergency management preparedness grant cycle, diabetes prevention program, and reported that she is serving her third year on the IPHA Board
