 - Discussed a proposed easement from Meadowvale Dairy in section 25 of Settlers Township. Meadowvale Dairy is requesting 60 feet of easement from the County. Julius will continue to examine the location further before giving the Board his recommendation.
 - Updated the Board on secondary road activities as well as the 2017 Construction Map.
 - Distributed the Official Report of Sioux County Secondary Road Fund, as of October 31, 2017 for information.
